Staff overtime will be charged at R2,000/hour if function continues after the end time – needs to be pre-arranged

MENU PRICES: (subject to final confirmation 3 months ahead of event)

From R600 – R680 (minimum of 50 adult guests will be charged for wedding canapes, lunch/dinner) Children 1-11 years special kids meal package at fixed price or less 50 % on banqueting menu options

Bar service: Bar deposit basis with or without limitations and/or cash bar; corkage fee of R90 per 750ml wine/champagne bottle only for items not on our wine list, Beverage and wine prices charged at current price lists as on day of wedding; bar overtime of R2,000 per hour after 24h00.

ACCOMMODATION:

20 rooms are available accommodating a total of 53 guests at discounted rates subject to **a minimum of 50 adult wedding guests or 20 rooms booked** for the wedding night. Check-in time from 14h00 and latest checkout time by 10h00.

The 2nd night accommodation incentive includes dinner at Kingfisher Restaurant or, if more than 30 guests booked at Mongena, a 3 course braai/barbeque dinner offered at no extra charge at a venue different to the wedding reception venue.

Guest transfers to and from the venue included in this incentive offer.

Other accommodation in close proximity to lodge = variety of lodges with about 60 rooms

ACTIVITIES

Wedding guests receive 10 % discount off published activity rates for the specific wedding date of guided game drives, guided bushwalks and sunset cruises which need to be pre-booked.

INCLUDED IN VENUE HIRE FEES:

- ♥ Family room/honeymoon suite for night of wedding on bed & breakfast basis
- ♥ 2 bottles champagne for wedding couple
- ♥ Use of game vehicle for 1 hour for wedding photographs in big five game reserve
- ♥ White wall candles in chapel (if applicable)
- ♥ Hire and use of specified venue, cleaning of venue, tables, standard chairs, setting of tables with white linen tablecloths and white linen serviettes, crockery, cutlery, waiters and barmen excluding recommended guideline of 10 % service tip.
- ♥ Professional wedding coordination services before and on day of wedding.
- ♥ VAT included in all published rates.

NOT INCLUDED:

- ♥ Photographer, DJ, flowers, candles (except those on wall in chapel)
- ♥ Special colour overlays, sashes, chair covers, fairy light in lapa roof, draping or any other décor items, free standing chandelabre in chapel
- ♥ Voluntary gratuity guideline of 10 % on pre-arranged bar and meal account
- ♥ Bar deposit if applicable
- ♥ Breakage deposit of R2000
- ♥ Dinokeng Game Reserve conservation levies

TERMS AND CONDITIONS: (See also wedding venue agreement letter)

Non-refundable deposit equivalent to venue hire to book and confirm date.

20 % of accommodation fees are payable upon booking.

100 % of accommodation fees payable 14 days before wedding date.

100 % of function, décor and catering arrangements is payable 14 days in advance of event.

Deposit for bar account payable 14 days in advance of event.

Refundable breakage deposit of R2000 payable 14 days in advance of event.

Cancellation clauses:

1. Venue hire paid is non-refundable at any stage; weddings can be moved or postponed to another date subject to Management discretion with price adjustments should the new date fall into a different calendar year.
2. 30-15 days prior to arrival a 100 % cancellation fee will be applicable on all deposits paid for rooms, additional décor and subcontractors.
3. 14 days and less prior to function date, a 100% cancellation fee is applicable for all function, accommodation and catering requirements reserved.
